GRIMESDALE GARAGE SALE. Remember that the neighborhood garage sale will be held on **Saturday**, **July 24**, **from 8 a.m. to 2 p.m**. Although an ad will be printed in the *Times-News* and signs will be placed at the Brookside Camp entrances to Grimesdale, you should put balloons or a sign in your front yard on the day of the sale if you want to participate.

Celebrate the success of your garage sale (or the advent of mid-summer) by attending the ice cream social in the Grimesdale Community Park on **Sunday**, **July 25**, **from 2 to 3 p.m.** (If it rains that afternoon, the event will be postponed until the following Sunday, August 1, during the same hour.) AIR APPARENT. "Best way to get rid of kitchen odors: Eat out" (Phyllis Diller, comedienne). "Best way to get rid of asphalt plant odors: Keep an odor log" (Lori Cherry, Environmental Program Supervisor, N.C. Division of Air Quality). As we mentioned in the last issue of the Gazette, we are conducting a study of the asphalt plant on Mud Creek to help ensure its adherence to EPA standards regarding air quality. We urge you to participate in this study by maintaining an odor log. We've attached a simple form that you can use to record information whenever you smell offensive odors that may originate from the plant. In addition to other observations, you will record the weather conditions at the time you detect an odor. You can find specific weather data (temperature, wind direction, etc.) by accessing the Grimesdale website (see masthead) and clicking on "Grimesdale Weather," which links to the weather station in Joe Stefanko's yard on Florida Drive. If you don't have a computer, just record what you can observe (hot, humid, cloudy, windy, drizzling, etc.). We're hoping for many participants throughout Grimesdale, especially those who live closest to the plant, because no resident is home or outside every minute of the day, and thus, no resident can maintain a complete log. Please keep a log from today through September 30. Even if you'll be away (on vacation, business, etc.) for several days or weeks, keeping a log when you're at home will be very helpful to our cause.
