**SUNSHINE REPORT.** On behalf of the Grimesdale community, Ruth Musolff, our Sunshine Director, sent a sympathy card to the family of Kate Buchanan of Cardinal Lane, who passed away in December. **ESCAPE FROM THE TWILIGHT ZONE.** Upon the recommendation of the Planning Board, the Henderson County Board of Commissioners voted unanimously on Monday, January 7, to rezone the neighborhoods of Grimesdale, Hickory Hill, and Cannon Woods from R1 to R2. This was the final step in the long process toward rezoning. Grimesdale and its two neighboring communities are now protected from multifamily housing, such as apartment complexes, and their accompanying headaches, such as increased traffic and noise. We would like to thank all those residents who voted for rezoning on the Planning Board's survey questionnaire and especially those who helped persuade the Planning Board and County Commissioners by writing letters, attending meetings, and speaking at those meetings. Welcome to the Comfort Zone!

**CAR BURGLAR ARRESTED.** As reported in the *Times-News* in mid-December, Hendersonville police arrested a young man in his early 20s and charged him with burglarizing vehicles. Although we are uncertain if this man is responsible for the thefts from unlocked vehicles in Grimesdale, GHA President Chuck Mason has noted that no resident has reported a theft to him since early December, before the young man was arrested. We can only hope that the police got their man as well as ours. But to be safe, continue to lock your vehicles, remove valuable items from them (or hide them from sight), keep a watch on your neighbors' properties, and report any suspicious activity to the Sheriff's Office at 911 (emergency) or 697-4596 (non-emergency).
