BOARD MEETING & TREASURER'S REPORT. The January 2014 GHA Board Meeting was held at the home of Joyce and Chuck Mason. As of December 31, our bank balance was \$3,997.71. We had 95 paid members for 2013, the highest annual total since 1998, when 104 households became GHA members. As of this writing, we have five paid members for 2014. BEAR WITH US. We can't bear to think about how frightened some folks must have been when a mama bear and her two cubs roamed through the streets of Grimesdale on October 21. We thank our "cub scouts" who spotted the ursine family and warned residents by e-mail or phone call. We hope you were able to bear up under the strain and found a safe and secure cubbyhole until the danger passed. Fortunately (as far as we know), no resident or pet was harmed that day, although a few garbage cans suffered cuts and bruises. If a bear should appear again in our neighborhood, we suggest that you call him "Nate." Then you could tell him, "Hi, bear Nate!" as he wanders through your yard. Let us paws for a moment while we get our bearings. . . . Although some residents may have felt it was a grizzly experience, others may have found being this close to nature unbearably exciting. But please bear in mind that all wildlife can pose a danger. We hope this caveat bears fruit. Keep yourself and your loved ones safe so you can give each other bear hugs for many years to come. (We ask your forbearance for our overbearing wordplay in this paragraph. The temptation was more than we could bear! We hope you won't bear a grudge but will just grin and bear it.)

WHEN A BARK IS WORSE THAN A BITE.

The hills are alive with the sound of barking....

We've received several complaints from residents about barking dogs in the neighborhood. If a dog barks a few notes now and then, it's no problem. However, when a dog is compelled to bark an entire opera, nearby residents become prone to headaches and high blood pressure, may lose their patience and equanimity, and might even call the Sheriff's Office (697-4596) to report the nuisance dog. An animal that "barks, bays, yelps, howls, cries, squawks, or makes any other unreasonably loud disturbing noise continuously or incessantly for a period of 10 minutes or intermittently for a period of 30 minutes or more" is violating the Henderson County Noise Ordinance. Please don't leave your dogs outside if they are fond of barking. Consider the welfare of your neighbors so they won't have to consider calling the Sheriff's Office. If everyone makes an effort, we can all avoid barking up the wrong tree.

IT'S INCUMBENT UPON THE INCUMBENTS. Because of a lack of volunteers, we're fortunate that the GHA officers who served last year agreed to serve again this year.
