BOARD MEETING & TREASURER'S REPORT. Due to ongoing Coronavirus restrictions, no GHA meeting was held in April. The next board meeting has been rescheduled for Tuesday, June 23rd via video conferencing (further instructions below). As of March 31st, 2020, we have \$3,184.75 in the bank, compared to \$2,934.93 for March 31st, 2019.

JULY ICE CREAM SOCIAL AND BOARD MEETING. Our original plan was to have the ice cream social and the GHA board meeting on Sunday, July 19th in the park. Due to current restrictions, we've decided to have the board meeting via video conferencing on Tuesday, June 23rd at 7:00 PM. Below you will find detailed instructions on how to join the meeting. The ice cream social will be held on Sunday July 19th following current North Carolina "Safer at Home" restrictions. More details on that are also below. We care about the safety and health of all of our neighbors and are taking steps to ensure all Grimesdale Homes Association activities are as safe as possible during this pandemic.

JULY ICE CREAM SOCIAL. Our ice cream social will be held on Sunday, July 19th beginning at 2:00 PM. At this time, we will be following Phase 2 "Safer at Home" restrictions. Only 25 participants at any one time can be at the park for the event, and non-family groups should stay at least 6 feet apart. Please stay up to date on the current phase restrictions, as these could change prior to that date (and we will be following whatever guidelines are in place at that time). Please note that this attendance is at your own risk. Please use your judgement on whether this is an appropriate activity for you or your family. While we love to see our fellow Grimesdalian, we also want everyone to be healthy and safe! Special thanks to Bill Erickson for being the "host" of this event.

RECENT Q&A. The board answered questions from residents that may interest others. CHICKENS – per the county ordinances, chickens are allowed. But please be kind to your neighbor and resist that rooster – they

can be very loud (especially early in the morning). Stick with the chicks! **YARD SALE** – all Grimesdale Homes Association sponsored yard sales are canceled due to the current restrictions until further notice. **BURNING** – burn barrels are illegal in Henderson County. All burning of yard wastes requires a permit from the county which can be obtained on their website. Failure to do so can result in fines. **BEARS** – we've had a few bear sightings in the neighborhood. Be sure to keep trash in an enclosed area until ready for pickup or delivery to the waste station, and when bears are active in the area, take in birdfeeders. Let's keep our bears wild.

SPEEDING ON OUR STREETS. We once again have to address the speeding on our neighborhood streets. There are small children, families and elderly residents who all regularly walk the neighborhood for exercise and as a great stress reliever. Some of our streets have hidden curves and blind hills, making it dangerous if cars are speeding by. **PLEASE SLOW DOWN!** You could save a life – no one wants to hurt another person due to speeding. Also, if you're walking, please follow pedestrian safety guidelines.

- Whenever possible, walk on the sidewalk; if no sidewalk is available, walk facing traffic
- Cross streets at crosswalks; If no crosswalk is available and your view is blocked, move to a place where you can see oncoming traffic
- Look left, right and left again before crossing the street, making eye contact with drivers of oncoming vehicles to make sure they see you
- Stay alert – avoid cell phone use and wearing earbuds
- Wear bright and/or reflective clothing, and use a flashlight at night
- Watch for cars entering or exiting driveways or backing up in parking lots
- Children younger than 10 should cross the street with an adult
